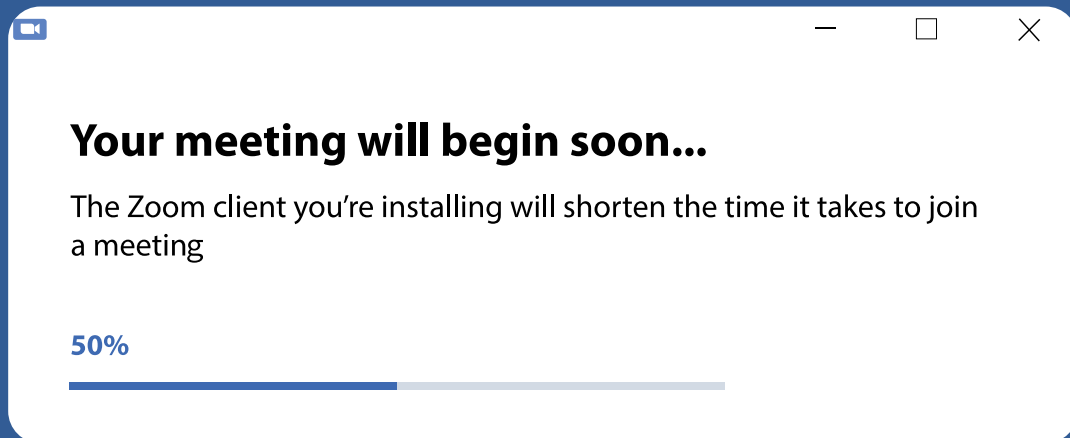

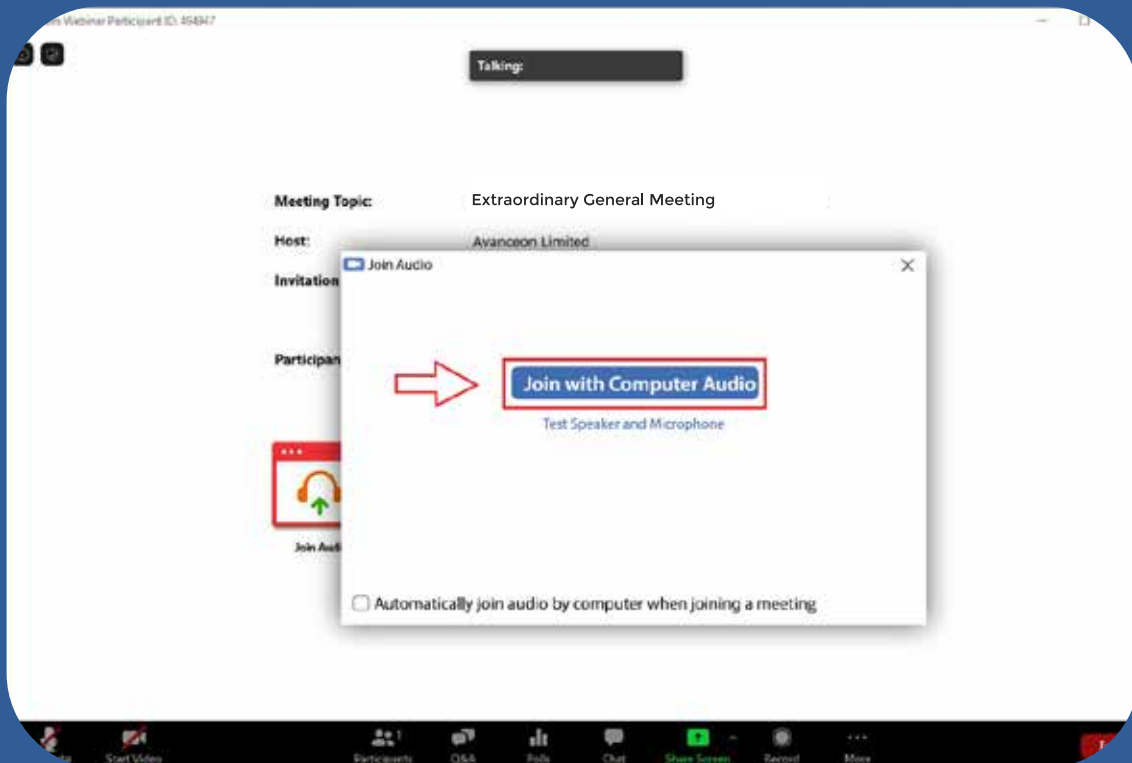

Open the Application to start installation. Once the installation is complete, the Zoom application will launch automatically.



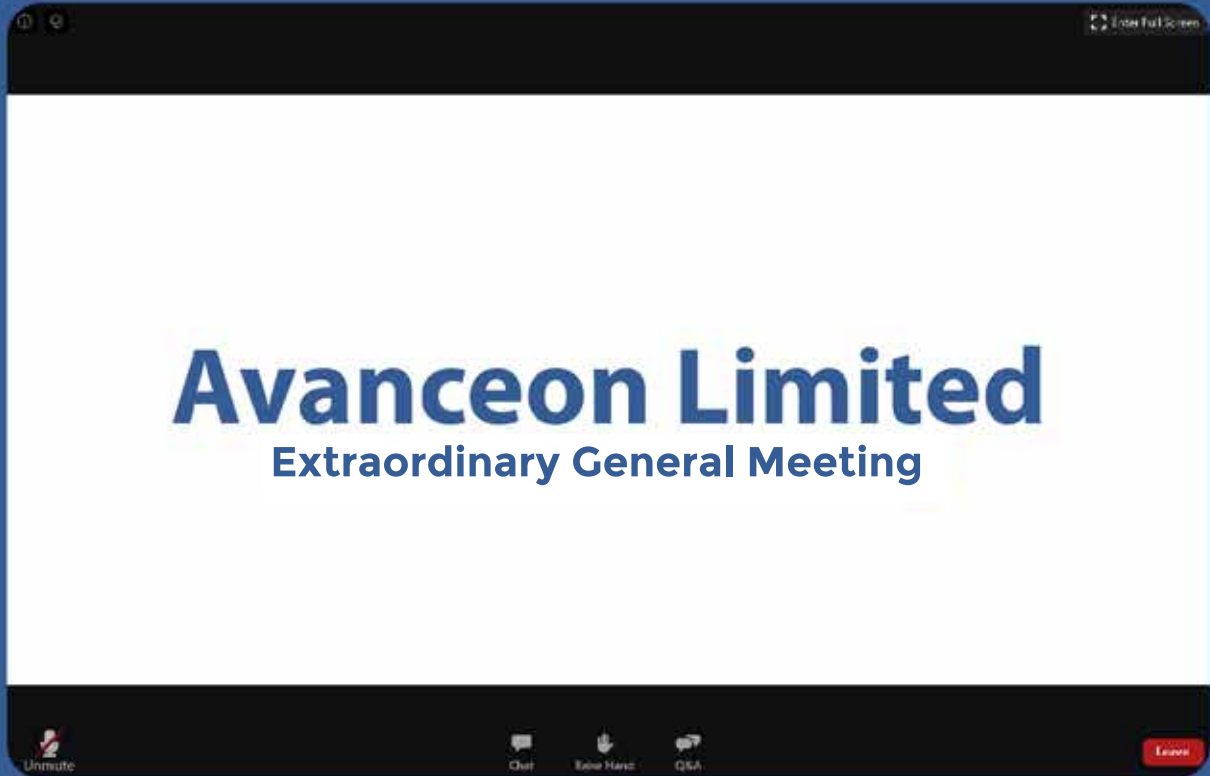
✓ Step # 7

You will see a prompt for 'Join Audio'. Click on "Join Computer audio"

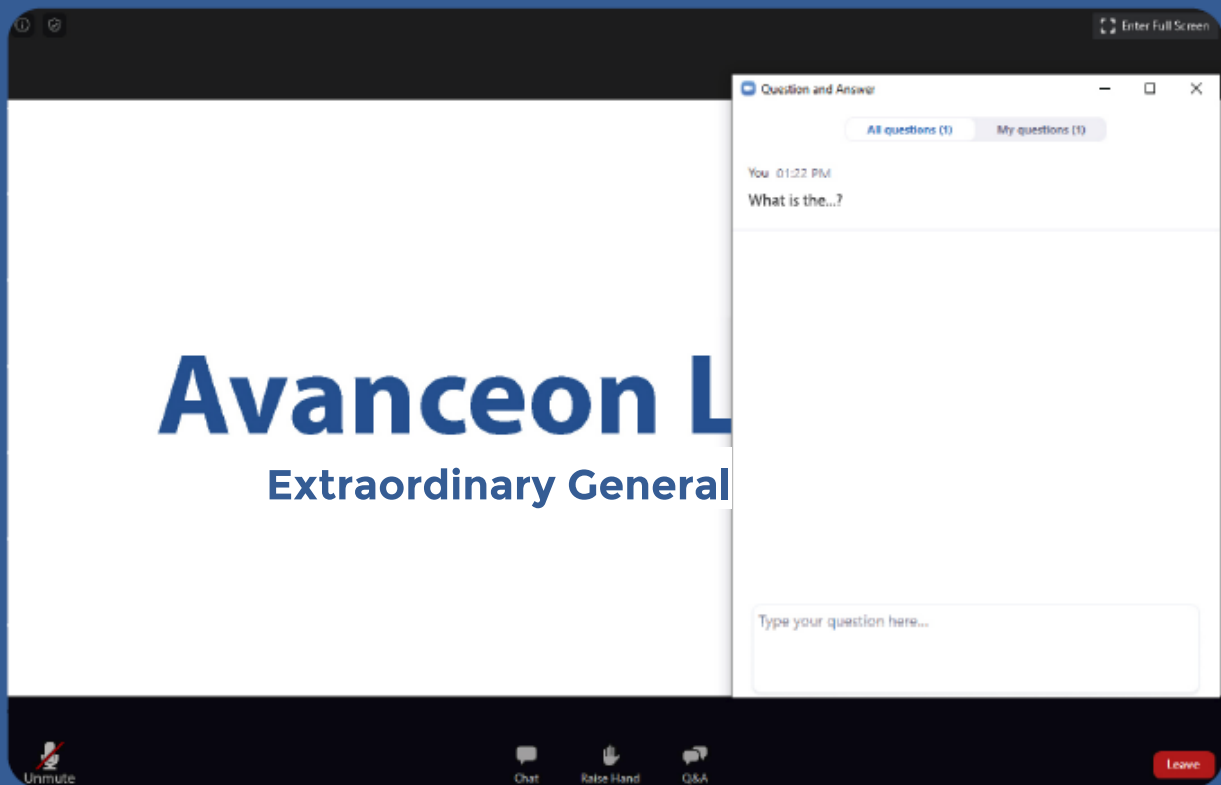
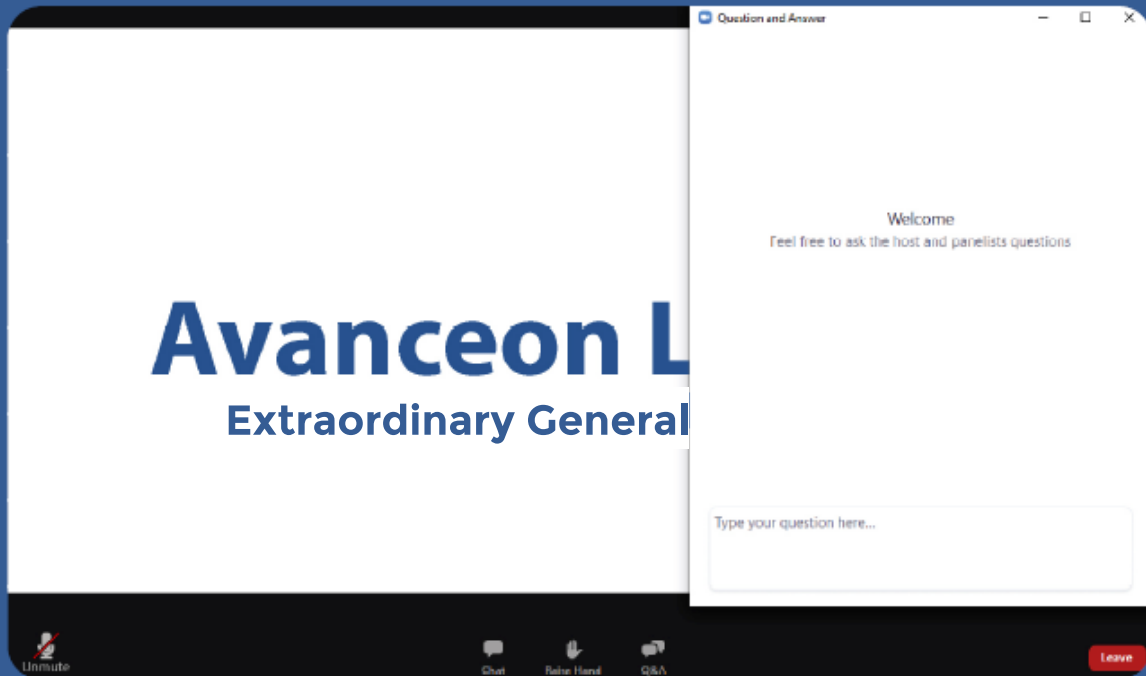
